



### Improvements to Foreign Qualification Recognition (FQR)

Objective: To determine barriers to foreign qualification recognition, labour mobility, and identify opportunities for improvements in reducing existing barriers for newcomers

## Why We Are Doing This

- Newfoundland and Labrador has the highest median age in the country, with a significant number of expected retirements and people leaving the workforce in the coming years.
- There are gaps in skilled and available labour in the provincial economy and this is particularly acute in a number of health care occupations.
- Many professionals face challenges to obtain full licensure, resulting in lengthy, and costly processes.
- Our goal is to welcome 5,100 newcomers per year by 2026. To achieve this goal, we must remove barriers to foreign qualification recognition.



## Aging population, NL, 1971 vs 2021






## Aging population, NL, 2031 & 2041 - Projections



## **Occupational Forecast for Health Occupations (2021-2030)**

#### **Health**

Occupations in this category are concerned with providing health care services directly to patients and occupations that provide technical support to medical staff.



#### <u>Key Points</u>

- 3,284 job openings
- 4.1 per cent of all forecasted job openings
- Rating of 2.0 (balanced)

#### Occupations with the most job openings:

- Professional occupations in nursing (934)
- Assisting occupations in support of health services (667)
- Licensed practical nurses (487)
- Physicians, dentists and veterinarians (272)
- Medical laboratory technologists and technicians (177)
- Other medical technologists and technicians (including veterinary) (147)




# Occupational Forecast for Occupations in Natural and Applied Sciences and Related (2021-2030)

Natural and Applied Sciences and Related

This category includes occupations in sciences, engineering, architecture and information technology.

#### <u>Key Points</u>

- 6,256 job openings
- 7.7 per cent of all forecasted job openings
- Rating of 2.5 (balanced)

- Computer system analysts and other mathematical occupations (615)
- Technical occupations in computer and information systems (541)
- Other technical inspectors and regulatory officers (513)
- Air pilots, flight engineers and flying instructors (485)
- Technical occupations in life sciences (433)
- Technical occupations in physical sciences (312)




# Occupational Forecast for Occupations in Education, Law and Social, Community and Government Services (2021-2030)

#### Education, Law and Social, Community and Government Services

Occupations in this category are concerned with law, teaching, counselling, conducting social science research, developing government policy, and administering government and other programs. Occupations providing religious services and leadership are also included in this category.

#### Key Points

- 6,348 job openings
- 7.8 per cent of all forecasted job openings
- Rating of 2.2 (balanced)

- Home support workers, housekeepers and related (1,703)
- Secondary and elementary school teachers and educational counsellors (675)
- Social and community services professionals (611)
- Policy and program researchers, consultants and officers (596)
- Occupations in frontline public protection services (556)
- College and other vocational instructors (469)




# **Occupational Forecast for Trades, Transport and Equipment Operators and Related Occupations (2021-2030)**

### Trades, Transport and Equipment Operators and Related

These occupations include trades supervisors and contractors, construction and mechanical tradespersons, operators of transportation and heavy equipment and trades helpers. These occupations are found in a wide range of industrial sectors, with many in the construction and transportation industries.

#### <u>Key Points</u>

- 10,653 job openings
- 13.1 per cent of all forecasted job openings
- Rating of 2.4 (balanced)

- Transport truck drivers (1,634)
- Material handlers (1,040)
- Construction millwrights and industrial mechanics (866)
- Automotive service technicians, truck and bus mechanics and mechanical engineers (820)

## What Other Jurisdictions Are Doing

<u>Alberta</u> - New Labour Mobility Act which provides a framework for government to impose broad new requirements on regulatory bodies to improve labour mobility.

The new legislation applies to over 100 associations and colleges in the province, including major regulatory bodies that regulate paramedics, licensed practical nurses, registered nurses, physicians, engineers, lawyers, dentists, and many others.

<u>Ontario</u> - Working for Workers Act - Schedule 3 of the legislation is focused in large part on recognition of foreign credentials, making it easier for internationally-trained professionals to be recognized in that province by removing the requirement to have Canadian work experience, eliminating duplicative official language proficiency testing, providing new processes for emergency licensure, and ensuring licensing processes are completed in a timely manner.

The legislation would apply to non-health regulated professions and compulsory trades such as professional engineers, architects, plumbers, electricians, accountants, hairstylists, teachers and early childhood educators.

Bill 98, Fairness for Ontario's Internationally Trained Workers Act, 2022 - enacts the Fairness for Ontario's Internationally Trained Workers Act, 2022. Establishes a Foreign Credential Recognition Advisory Committee that makes recommendations to the Minister regarding the employment of internationally trained workers and establishes an Internationally Trained and Educated Healthcare Professions Advisory Committee that makes recommendations to the Minister regarding the employment of internationally trained and educated healthcare professionals.

## What Other Jurisdictions Are Doing

<u>Manitoba</u> - Fair Registration Practices in Regulated Professions Amendment Act which is intended to further reduce barriers for internationally educated professionals to register in Manitoba's 31 self-regulated professions.

- Clarifying the requirement for professions to ensure registration requirements and assessments for Ο internationally educated applicants are necessary.
- Obligating self-regulatory bodies of changes to their assessment and registration practices. Ο
- Allowing the establishment of a timeliness standard for registration of qualified internationally educated Ο applicants by regulation.

**Saskatchewan** - The Labour Mobility and Fair Registration Practices Act. The Act will reduce barriers to working in the province to ensure skilled workers can have their skills and credentials recognized, while assisting employers in filling jobs across a number of key sectors, such as healthcare, construction and IT.

**Quebec** - \$130 million in funding announced on December 7, 2021 aimed at a new two-year action plan. The plan aims to develop projects in areas such as recruitment, skills assessment, personalized support, refresher training, skills and credential recognition as their government Newfoundland looks to address a chronic labour shortage.
